## Friends Outside

Mission is to improve the quality of life of families and children impacted by incarceration and assist with successful community reentry and family reunification for those transitioning from confinement to freedom. Friends Outside offers caring, evidence-based services to adults and youth who are incarcerated, reentering the community or at risk, so that they, their families and neighborhoods can be safe and thrive.

Visitor Centers offer a comfortable, welcoming place of respite. Centers offer comfortable seating areas, restrooms, children's toys, changing tables for babies and a well-trained, understanding staff.

**Clothing:** Sometimes visitors arrive at the prison dressed in clothing that violates institutional rules for visitor attire. Visitor Centers loan appropriate clothing, ensuring that the visit can still take place and that the visitors feel comfortable. Clothing is available for men, women and children in a wide range of sizes.

**Transportation:** Passenger van transportation between the institution and local public transportation terminals is provided for visitors, who may arrive at a transit station located some distance from the prison. Friends Outside drivers both pick up and deliver visitors. Sometimes the ride provides an opportunity for visitors to connect with others experiencing similar situations.

**Resources and Information:** Visitors may need directions, information about local restaurants or motels, or public transportation schedules. Families may also be in need of emergency assistance such as shelters, food banks and social services. Friends Outside staff offer support and assistance.

**Information regarding visiting rules and regulations:** State prison rules and regulations can be confusing and intimidating. Friends Outside's Visitor Center staffs are available to explain regulations and help visitors to comply.

## Help with Income Loss

### Unemployment Benefits

You may be eligible for unemployment if:

- If an employer has either reduced your work hours or shut down due to COVID-19.
- If you have to miss work to care for you children due to school closures, and you do not have alternative care or remote work options.

## Rent or Mortgage

Gov. Gavin Newsom issued an executive order 3/17/20 that allows local jurisdictions to halt evictions for renters and homeowners, as well as requests banks and financial institutions to stop foreclosures, through May 31. This does not prevent eviction or foreclosure.

For Fresno renters, the City Council established a month-long moratorium on evictions on March 19. Renters must formally notify their landlord if the COVID-19 crisis has impacted their ability to pay rent. Landlords would then be required to allow at least six months for tenants to catch up on their rent.

If you live in public housing, the Department of Housing and Urban Development (HUD) has announced a national eviction moratorium, for tenants who cannot pay rent due to coronavirus impacts. For

homeowners with a Federal Housing Administration (FHA) backed mortgage, HUD announced that it is suspending all foreclosure and eviction actions for the next 60 days, through mid-May. Learn more at the **HUD website** <https://www.hud.gov/>.

## Social and Emotional Wellness Tips

In these challenging times, it's important to be mindful of your own mental and emotional health and the mental and emotional wellness of your family. Take time each day to do things that bring you joy or help you relax: take a walk (while maintaining physical distancing guidelines), play a game with your family, cook a healthy meal together, or watch a favorite movie. Here are some tips to take care of yourself during this difficult time:

- Limit your time on social media/news outlets – constant immersion in stressful information (and sometimes misinformation!) can cause negative emotional impact.
- Obtain updates and news from reliable sources, such as your state, county and city government and public health departments, the CDC and World Health Organization (WHO).
- Social distancing practices are important, but so are human relationships. In-person contact should be limited, but not use of technology! Stay in touch with friends and family with phone calls, FaceTime or other video chat services.
- Maintain your normal sleep/wake cycles and create a daily routine if you are experiencing schedule changes due to school closures, work closures/reduction in hours.
- Keeping a consistent routine will help reduce anxiety and offer healthy means of distraction.
- Take care of your body by eating healthy foods, getting enough rest and drinking plenty of fluids.
